7. The bidding process will be accepted only through e-Tendering platform. 9. For e-Tendering, BSNL has engaged e-portal maintained by NIC, New Delhi. The agency intending to participate in tendering process shall have to register with www.etenders.gov.in, for details kindly visit website www.etenders.gov.in. The intending bidders must have Class-III digital signature to submit the bid.
10. On opening date, the contractor can login and see the bid opening process. After opening of bids he will receive the competitor bid sheet.
11. Contractor must ensure to quote rate of each item. The column meant for quoting rate in figures appears in yellow colour and moment rate is entered, it turns green. In addition to this, while selecting any of the cells a warning appears that if any cell is left blank the same shall be treated as "0". Therefore if any cell is left blank and no rate is quoted by the bidder, rate of such item shall be treated as "0" {Zero}.
12. Before e- tendering, the contractor shall inspect the site and fully acquaint himself about the condition with regard to accessibility of site and site nature and the extend of grounds, working condition, including stocking of materials, installation of T&P etc., and conditions affecting accommodation and movement of labour etc., required for the satisfactory execution of the contract. No claim whatsoever on such account shall be entertained by the BSNL in any circumstances.
13. The Bid can only be submitted after uploading the following scanned documents (all documents shall be self-attested) : –
 - a) Documentary proof of satisfying eligibility conditions as above.
 - b) Copy of PAN card, valid GST registration, CA certificate for turnover, EPF Registration certificate, ESI registration Certificate
 - c) Demand draft of cost of tender documents.

14. Originals of bank instruments such as DD or EMBG towards Tender Fee, EMD/ Bid Security respectively (if not submitted through e-payment mode), shall be submitted by bidder to O/o **Executive Engineer (E), BSNL Electrical Division-II, 6th Floor, BSNL Bhavan, Adarshnagar, Hyderabad on any date before or within 5 days of bid submission end date** failing which the tender bid (if already opened on basis of scanned copies uploaded in 1st electronic Envelope i.e. Technical Envelope, shall be rejected.
15. After submission of the bid online the contractor can re-submit revised bid any number of times but before last time and date of submission of bid as notified.
16. While submitting the revised bid, contractor can revise the rate of one or more item(s) any number of times (he need not re-enter rate of all the items) but before last time and date of submission of bid as notified.
17. The bid submitted shall become invalid and cost of bid & e-tender processing fees shall not be refunded if:
 - (i) The bidder is found ineligible.
 - (ii) The bidder does not upload all the documents as per check list.





18. Performance Guarantee (PG): -The Firm shall have to furnish **Performance guarantee @ 5%** of the contract value of the individual contract within two weeks of the date of issue of award letter in the form of Bank guarantee on a Nationalized/Scheduled bank in standard format **(Annexure-II)**/ CDR/ FDR/ DD. This period can be further extended by the Engineer-in-Charge up to a maximum period of two weeks on written request of contractor.
- This performance guarantee shall be submitted to the Electrical Division in the name of concerned Accounts officer of the SSA where work is to be executed and shall be valid for 12months from the date of actual completion of individual work.
19. Security deposit: -A sum @ 10% of the gross amount of the bill shall be deducted from each running bill of the contractor till the sum will amount to security deposit of 10% **(i/c 5% PBG)** of actual work done. This Security Deposit shall be released after an observation period of 12 months after the date of completion of work.
20. The acceptance of tender will rest with the **SE (E) BSNL** Hyderabad who does not bind himself to accept the lowest tender or any other tender & reserves to himself the Authority to reject lowest or all the tenders received without assigning any reason. All tenders in which any of the prescribed conditions are not fulfilled or incomplete in any respect are liable to be rejected. Tenders with any condition including that of conditional rebates shall be rejected forthwith summarily.
21. Canvassing in connection with tender is strictly prohibited & the tenders submitted by the contractors who resort to canvassing will be liable for rejection.
22. The BSNL reserves itself the right of accepting the whole or any part of the tender & the tenderer shall be bound to perform the same at the rates quoted.
23. The tenderer should give a certificate that none of his/her relative is employed in BSNL units. In case of proprietorship firm, certificate will be given by the proprietor & for partnership firm certificate will be given by all the Directors of the company.
24. Near relatives of all BSNL employees either directly recruited or on deputation are prohibited from participation in tenders and execution of works in the different units of BSNL. The near relatives for this purpose are defined as:
- Members of a Hindu Undivided family.
 - They are husband and wife.
 - The one is related to the other in the manner as father, mother, son(s) & son' wife (daughter-in-law), Daughter(s) & daughter's husband (son-in-law), brother(s) & brother's wife, sister(s) & sister's husband (brother -in-law).
25. The company or firm or any other person is not permitted to tender for works in BSNL Unit in which his near relative (s) is (are) posted. The unit is defined as SSA/ Circle/ Chief Engineer/ Chief Archt./ Corporate office for non-executive employees and all SSA in a circle including circle office/Chief Eng./ Chief Archt./ Corporate office for executive employees (including those called as Gazetted officers at present). The tenderer should give a certificate that none of his/her such near relative is working

in the units as defined above where he is going to apply for tender/ work, for proprietorship, partnership firms & limited company certificate shall be given by the authorized signatory of the firm. Any breach of these conditions by the company or firm or any other person, the tender/work will be cancelled and performance guarantee will be forfeited at any stage whenever it is so noticed. BSNL will not pay any damages to the company or firm or the concerned person. The company or firm or the person will also be debarred for further participation in the concerned unit.

26. No employee in BSNL/ Govt. of India is allowed to work as a contractor for a period of two years of his retirement from service without the prior permission. The contract is liable to be cancelled if either the contractor or any of his employees is found at any time to be such a person who had not obtained the permission as aforesaid before submission of tender and engagement in the contractor's service.
27. The tender for the works shall not be witnessed by the contractor who himself/themselves has/ have tendered or who may and has/have tender for the same work. Failure to observe this condition would render tenders of the contractors tendering as witnessing the tender is/are liable for summarily rejection.
28. It will be obligatory on the part of the tenderer to sign each page of the Schedule of work and the tender documents for all the component parts and after the work is awarded he will have to enter into a separate agreement with the officer concerned.
29. Any tender not submitted in proper manner or not as per the directions of ONLINE submission, BSNL will be at liberty to take such action as it may deem fit without any reference to the tenderer.
30. The tenders for the work shall remain open for acceptance for a period of 90 days from the date of opening of the tenders. If any tenderer withdraws his tender before the said period or makes any modification in the terms and conditions of the tender which is not acceptable to the BSNL shall, without prejudice to any other right of remedy be at liberty to forfeit 50% (fifty percent only) of the said earnest money absolutely.
31. Extension of validity: In case, where the letter of award of work cannot be placed within the validity period of the tender, the BSNL can request all tenderers to extend the validity of their respective tenders by a reasonable period. While BSNL can make the request for extension, the tenderer is free to either extend the validity or refuse the request to extend the validity.
32. The contractor should read the tender documents carefully before submitting the tender. He should only submit his bid if he considers himself eligible and he is in possession of all the documents required.
33. Conditional tenders or tender with conditional rebates shall be summarily rejected.
34. Agreement shall be drawn with the successful Tenderer on prescribed Form No. BSNL EW-6/8, which is available on BSNL website <http://www.telangana.bsnl.co.in>. Tenderer shall quote his rates as per various terms and conditions of the said form.

 - b) Standard EW-8 form.
37. EPF PROVISIONS: The agency has to comply with the provision of EPF and miscellaneous provisions Act - 1952 and employees Provident Fund scheme-1952 as amended up to date in respect of labours /employees engaged by them for this work. Any consequences arising due to non-complying of provisions as specified above shall be of the sole responsibility of the firm only. The agency shall give an undertaking to this effect as per the prescribed proforma **(Annexure IV)**.
38. The site for the work shall be made available in parts.
39. If any terms and conditions mentioned in this NIT document are in contravention to BSNL EW6/EW 8 General Conditions of Contract, the terms and conditions mentioned in this document shall prevail.



GENERAL CONDITIONS

Scope of Modernisation & Maintenance:-

Scope of Modernisation of lifts includes, carrying out the activities as per the manufacturers schedule for keeping the system in the healthy condition, repairing/replacing the components required with the same or superior make for bringing the equipment to healthy condition. The make of replacement parts shall have to be approved by Engineer-in-charge if it is not same as that of faulty parts.

Methodology:

It is presumed that contractor shall undertake the stated responsibilities only through qualified and experienced staff. Service is to be provided round the clock round the year even on holidays. For preventive and break down maintenance the extra specialized labour shall be deployed based on manufacturers recommendations and as per the requirement to bring system to healthy condition with minimum equipment downtime. Notwithstanding the above it is the responsibility of the agency to provide required manpower to attend the complaints within the time frame specified as the tender is of comprehensive nature.

QUALIFICATIONS:



amount to security deposit of 10% of the value of work done including 3% Performance Guarantee.

36. Increase/ Decrease of tendered quantity

BSNL will have the right to increase or decrease up to 50% of the quantity of goods and services specified in the schedule of items without any change in the unit price or other terms and conditions at the time of award of contract. In exceptional and unavoidable cases BSNL can increase the quantity of goods and services beyond 50% of the tendered quantity without any change in tendered and accepted unit price and also other terms and conditions as applicable at the time of award of contract.

Note: The above item is applicable only in case of supply contracts items but not for comprehensive maintenance contracts.

37. Completion of work

The contract period for this work is 2 (Two) months and the same shall be completed by covering all aspects as mentioned in the "General Specification".

38. Extension of time

If the contractor shall desire an extension of time for completion of any pending repair work prior to handing over the site / sites to the new firm / contractor or back to BSNL on the grounds of his having been unavoidably hindered in its execution or on any other ground, he shall apply in writing to the Engineer – in – charge within 10 days of intimation to handover the site giving reasons on account of which he desires such extension as aforesaid, and the Engineer – in – charge shall, if in his opinion reasonable grounds to be shown therefore, authorize such provisional extension of time, if any, as in his opinion be necessary or proper.

39. Variation in Excise Duty – NOT APPLICABLE

- i. In case of statutory variation in Excise Duty in respect of EA sets only within the stipulated date of completion of individual agreement, the same shall be paid or recovered as per the actuals against documentary proof. However, beyond this period the department will take advantage of any duty reduction but will not pay extra on account of duty increase.
- ii. Price adjustment provision on account of change in Excise duty shall not apply in respect of equipment/component of equipment/materials other than EA sets.

Note: The above item is applicable only in case of supply contracts items but not for comprehensive Mtce contracts.

40. The Department reserves the right to accept the quantities in full or in parts.

- a) Tendered rates inclusive of taxes and levies payable under the respective statutes. 

TERMS AND CONDITIONS FOR MODERNISATION & MAINTENANCE OF LIFTS

The Contractor is referred to here as 'Contractor' or 'Agency' or 'Firm' and Bharat Sanchar Nigam Limited as BSNL represented by Executive Engineer (E), Electrical Division-I, Hyderabad and his representatives.

The original manufacturer is M/s KONE Elevators India Pvt Ltd., Secunderabad.

1. The prices shall be firm for the contract period. The contract can be extended up to six months 'or' more for the same rates as accepted for this contract.
2. The firm will use trained and appropriately skilled personnel, which it directly employs and/ or supervises. They will be qualified to keep the equipment properly adjusted and they will use all reasonable care to maintain the equipment in efficient, reliable and safe operating condition.
3. The firm will in accordance with the terms hereof, regularly examine, lubricate and adjust the equipment and generally carry out planned maintenance in a systematic and controlled manner using firm's developed techniques and expertise.
4. The firm will, repair or replace any parts detailed in the following section, which, are defective.

20. Damage to any installation of the BSNL due to the negligence of the agency's personnel shall be made good at the risk & cost of the agency.
21. In case any person leaving the organization or agency, the agency has to intimate well in advance for not giving any responsibility to that person.
22. The agency shall be responsible for the character and conduct of the staff employed. If any person found not satisfactory by the BSNL, he/she has to be removed from the site immediately and substitute must be posted.
